

Parking FAQs for Graduate Students

1. **How do I purchase a parking permit?**
 - You may [purchase your parking permit online](https://www.clarke.edu/faculty-and-staff/intranet-safety-and-security/) at <https://www.clarke.edu/faculty-and-staff/intranet-safety-and-security/>.
2. **Where can students park on campus WITH a parking permit?**
 - Clarke students can park in one of four parking lots in any area designated as student parking. Students cannot park in any lot designated as faculty/staff parking (i.e. directly behind the Atrium). 3. **Where can I park on campus WITHOUT a parking permit?**
 - You may park on the street.
4. **How can I pick up my parking permit if I am not able to get it from Student Accounts before Student Accounts closes?**
 - If you are not on campus during Student Accounts office hours, please contact security@clarke.edu to have your parking sticker mailed to you.
5. **Do I need to purchase a parking permit if I am an MSW student in the Hybrid Weekend program?**
 - No, if you are in the Hybrid Weekend MSW program and will only be parking in campus parking lots on Friday evenings and Saturdays, you do not need to purchase a parking permit.
6. **Do I need to purchase a parking permit if I am an online or hybrid student who only comes to campus on a few weekdays per month?**
 - If you would like to park in the campus lots during the weekday, yes, you would need to [purchase your parking permit online](#).
7. **Are temporary parking permits available?**
 - Yes, if a student has a visitor coming for the weekend, a temporary parking permit may be obtained for the visitor. Temporary parking permits are also available to students who need one; for example, if their car is being repaired and they are using a temporary car. Temporary permits are only good for two weeks and they may not be used repeatedly in place of a regular parking permit. Temporary parking permits are available in the safety and security office.
8. **Does Clarke issue parking tickets?**

9. **What are the parking fine amounts for parking violations at Clarke?**

10. **Where do I pay my parking fee if I am ticketed?**

11. **Do I need a parking permit to park in the campus lots in the summer?**
 - Campus Security does not typically ticket in the summer; however, if you buy a permit during the fall or spring semester prior to the current summer term, the permit is good throughout the summer. Students beginning their graduate program during the summer term do not need to purchase a parking permit to park in the lots during the summer.
